- **Make all checks and money orders payable** to the German Shepherd Dog Club of Western PA (GSDC of WPA)

- **Post Dated and Returned checks** do not constitute a valid entry and the Show Secretary will add a \$15.00 collection fee to the amount of each returned check
- **A recording fee** of \$.50 for each dog entered and an AKC Event Service fee of \$3.00 for each entry is collected and paid to the American Kennel Club.
- **Telegraph, Telephone and Unsigned Entries cannot be accepted.** Entries not on official AKC entry forms or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.
- **Express mail** entries must include the signature waiver allowing them to be left at the secretary's address.
- **Illegible entries** will not be processed and will be returned to the exhibitor.
- **No refund for duplicate entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.
- **Owners are responsible** for errors in making out entry forms. Please type or clearly print the information on entry forms to eliminate errors.

### \*\*\*From the intersection of Rt. 22 and Rt. 66:

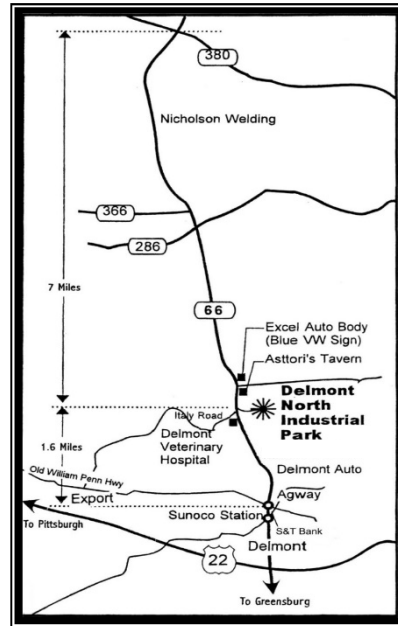
