NOTICE TO EXHIBITORS

A RECORDING FEE of \$.50 will be required for each dog entered at any licensed or member club show, obedience trial or tracking test. The Event Service fee of \$3.00 is collected by the show-giving club and paid to the American Kennel Club. (American Kennel Club Rule, Chapt. II, Sec. 2.) Rally Service Fee of \$3.00 is required per class for each entry of each dog. (American Kennel Club Rule, Chapt. I, Sec. 3.)

ENTRY FORMS MUST BE SIGNED at the bottom by the owner or the owner's duly authorized agent, otherwise entry cannot be accepted.

MAKE CHECKS & MONEY ORDERS payable to the G.S.D.C. of NORTHERN OHIO, INC. **ATTENTION CANADIAN EXHIBITORS**. We can ONLY ACCEPT Bank Drafts or Money orders payable in U. S. Funds. **RETURNED CHECKS** do NOT constitute a valid Entry. A **collection fee** of **\$40.00** will be added to each returned check.

ENTRIES WILL NOT BE ACCEPTED WITHOUT CORRECT PAYMENT OF ENTRY FEES.

ERRORS ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, whoever may make such errors and no entry fee will be refunded in event of such errors or cancellation of entries, after the published closing date. Please **TYPE OR PRINT "CLEARLY"** the information on entry forms to eliminate errors.

DECLINATION OF ENTRIES: GSDC of Northern Ohio, Inc. may decline any entries and may remove any dog on account of disease, viciousness or other cause and no one shall have any claims against GSDC of Northern Ohio, Inc. or any official thereof.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.

ALL DOGS PRESENT MUST BE ON A LEASH or otherwise restricted except when in the exercise ring.
