Canadian exhibitors will please make all checks and money orders payable in U. S. Funds.

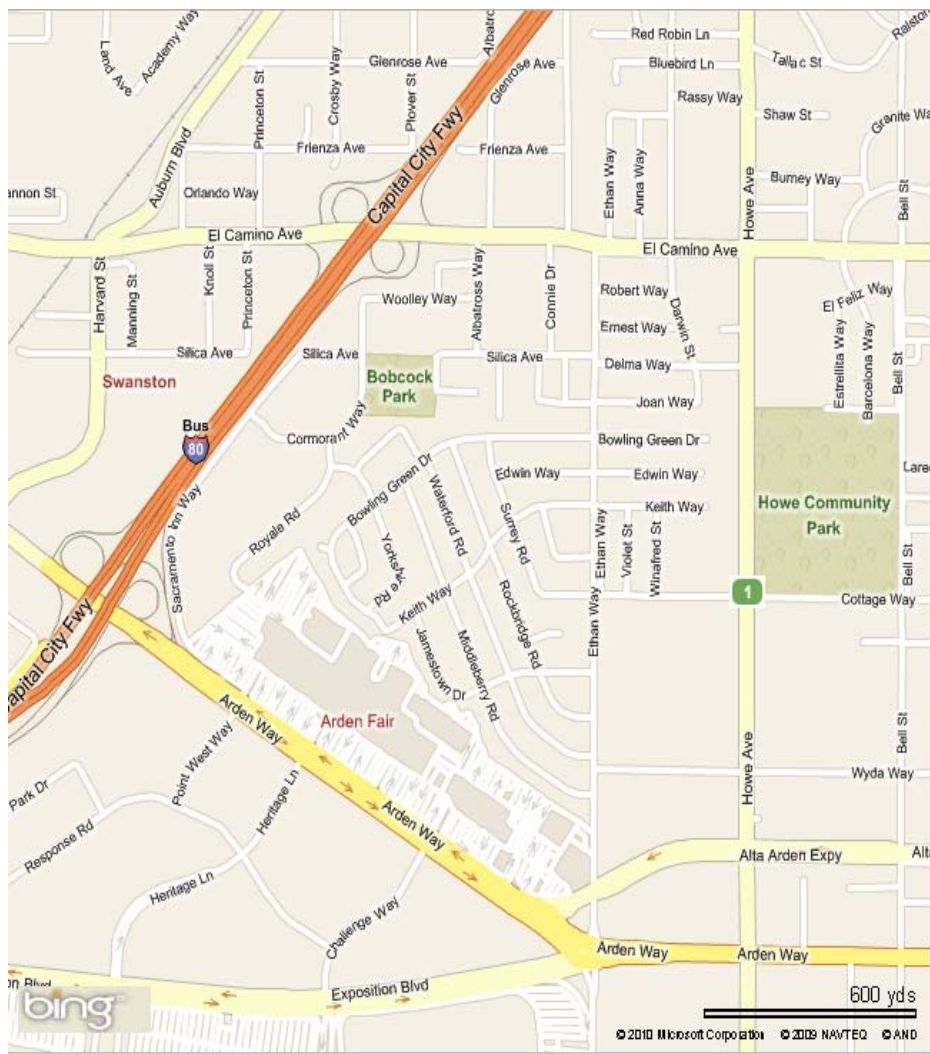
