### Notice to Exhibitors

1. **Entries close at 6:00 PM Wednesday, January 24, 2018** after which time entries cannot be accepted, canceled, changed or substituted, except as provided for in Chapter 11 Section 6 of the dog show Rules, and no entry fees will be refunded. There will be a \$2.00 fee charged for cancellation of an entry prior to the closing of entries.
2. **Entries not on Official AKC Forms or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC entry form are not acceptable. Entry Form must show the name of the Club and the date of the show. Entry Form MUST BE SIGNED.**
3. Dogs need be present only for their judging. Dogs not needed for further judging may be removed from the show grounds.
4. It is advised that owners and agents be familiar with the Agreement on the reverse side of the entry form.
5. To transfer a dog from one of the regular classes to Best of Breed Competition requires that the owner or agent notify the Show Secretary at least one half hour prior to the judging of the first class at this show.
6. All persons attending this dog show hereby waive any claim for damages against The Santa Maria/ San Luis Bay German Shepherd Dog Club or its members, OR the Santa Maria Elks Lodge or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

### Junior Showmanship Competition

NOTE – Effective January 1, 1989

AKC Junior Handler Numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club – PHONE: (919) 854-0195

**NOVICE JUNIOR CLASS:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.  
**OPEN JUNIOR CLASS:** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the third (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

**(3) Junior, Intermediate and Senior Classes:** Each of the regular classes may be divided by age into Junior, Intermediate and Senior Classes, provided the division is specified in the premium list. A Junior Class shall be for boys and girls who are at least 9 years old and under 12 years old on the day of the show. The Intermediate Class shall be for boys and girls who are at least 12 years old and under 15 years old on the day of the show. The Senior Class shall be for boys and girls who are at least 15 years old and under 18 years old on the day of the show.

**AGREEMENT**

I (we) acknowledge that the 'Rules Applying to Dog Shows' and, if this entry is for an Obedience trial, the 'Obedience Regulations,' have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned or by the negligence of any other person, or any other cause or causes.

**INSTRUCTIONS**

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard), Collies (rough, smooth).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a Championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to AKC. (For complete rule refer to Chapter 11, Section 3).
