- **Telegraph, Telephone and Unsigned Entries cannot be accepted.** Entries not on official AKC entry forms or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.
- **Express mail** entries must include the signature waiver allowing them to be left at the secretary's address.
- **Illegible entries** will not be processed and will be returned to the exhibitor.

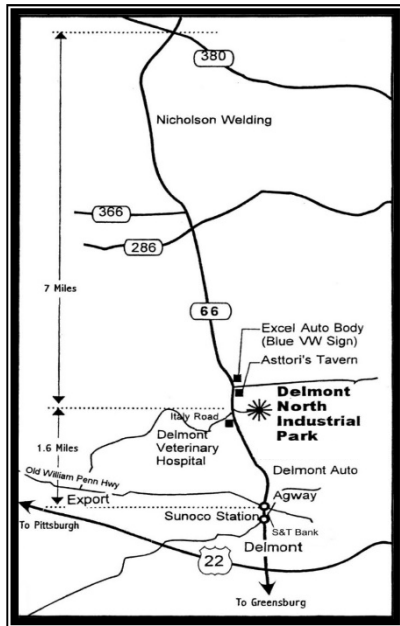
*****From the intersection of Rt. 22 and Rt. 66:**
