No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. *For complete details see Rules Applying to Dog Shows, Chapter 11, Section 1.*

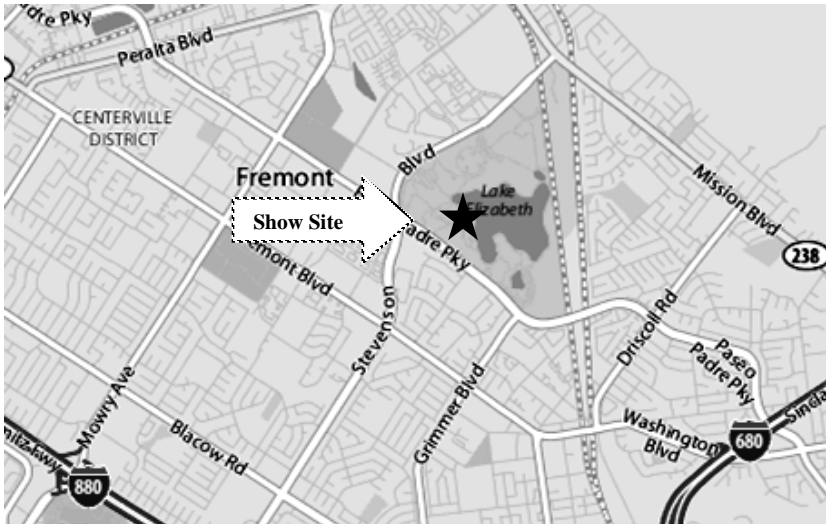

1. IF MONEY IS OWED TO GERMAN SHEPHERD DOG FANCIERS OF NORTHERN CALIFORNIA, ENTRIES AND PERSONAL CHECKS WILL NOT BE ACCEPTED UNTIL ALL MONEY OWED IS REMITTED BY MONEY ORDER OR CASHIERS CHECK. RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY.
2. The club assumes no responsibility for a wrong entry. Please PRINT or TYPE all information on entry blanks.
3. During the hours of judging, owners are to be on call and to have their dog ready to be brought into the judging ring promptly so the judging will not be delayed.
4. It is the responsibility of the exhibitor to have his or her dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs are alone responsible for the presence of their dogs in the judging rings.
5. There is no rule of this Club or of the AKC that requires a judge to wait for an owner or handler to bring his or her dog into the ring.
6. An exhibitor whose dog is eligible for an award must be present or have an appointed representative to accept the award for him or her.
7. Entry fees will not be refunded if the dog is absent, disqualified, sick, lame, in season, excused by veterinarian or judge, or barred from competition by action of the show committee.
8. Exhibitors and handlers will be held responsible for clean conditions in and around their crates.
9. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is understood that the exhibitor will exercise control over his or her children on the day of the show.
10. The Club assumes no responsibility for dogs or equipment left unattended.
11. All dogs must be kept on leash.
