DIRECTIONS TO THE SHOW SITE FROM THE NORTH OR SOUTH ON I-5: Take the Auburn Exit (Hwy. 18). Go to Auburn and take the Enumclaw Exit to Highway 164. Follow the signs to Enumclaw (Highway 410), just before Enumclaw. Turn right on 244th, go to 456th and turn left. It becomes Warner. Stay on Warner to the fairgrounds.

GOING SOUTH ON I-405 OR COMING FROM THE RENTON AREA – Go east on Maple Valley Highway (Hwy. 169), go through Black Diamond and continue on 416th SE, turn left then follow signs to the fairgrounds.

(e.g. Open Class on Day 1 and American-Bred Class on Day 2), or, if you are entering an additional class on any of the days (Open Class on Day 1 and Open Class plus Jr. Showmanship on Day 2 or Open Class and Novice A Obedience on Day 2.)

The German Shepherd Dog Club of America offers the Best of Breed Animal a vintage medallion as described below:

The German Shepherd Dog Club of America, Inc. is celebrating the 108th year of the German Shepherd Dog by awarding a vintage Bronze (or Copper) Medallion to the winners of Best of Breed and High Combined at Regional Specialty Shows. This medallion shows "Shepherd Dog Club of America". On May 22, 1918 AKC demanded that "German" be removed from the title of our club as well as the name of our dog. It suggested that we consider one of three suggestions: The Police Dog, American Shepherd Dog or American Sheep Dog. The club had 60 days to make a decision and respond to AKC. The membership was asked for their recommendations and our club responded to AKC that we would be the Shepherd Dog. This continued to the early 1930's, however, the medallion was used until 2006 when the club logo was used to remake the new medallions that have been used in recent times. Congratulations on your win! We are pleased to honor your accomplishment with this limited vintage medallion and proud to be able to share this small piece of the GSDCA's history with you.
