Entries close Wednesday August 11, 2021 at 7:00 pm, after which time entries will not be accepted, cancelled, substituted, transferred, or changed.

A recording and event service fee charge of \$3.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class, the Recording Fee is to be collected on the first entry only (American Kennel Club Rule, Chapter 11, Section 2 amended).

The Show Giving Club assumes NO responsibility for any loss, damage, or injury for any exhibitors, handlers, their dogs, or property. The Show Giving Club assumes NO responsibility for any children on the site.

All Cash Prizes, Ribbons, and Trophies will be given in the ring to the person showing the dog. Claims for ribbons, trophies, or prize money must be made in the ring before the judging of the class is over.

The German Shepherd Dog Training Club of Chicago, Inc. disclaims any liability for cash prizes, ribbons, and trophies after the judging of the class is over. Absolutely No Trophies, Ribbons, or Prizes will be mailed.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

No dogs will be allowed on the show grounds that are not entered in this trial. All dogs entered must remain on leash, except as required in the ring for competition or be confined to their crates.

Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season and the event secretary is notified no later than 1 half hour prior to the start of the first class in the trial, the club is required to refund the entry fee. Refund of Entry fees for females that come into season after the closing date of the Trial, minus \$8.00 per run, will be made upon receipt of the **Original Veterinarian's Certification Letter** confirming the female is in season.

The German Shepherd Dog Training Club of Chicago, Inc. believes in responsible dog ownership. For your convenience, an exercise area is provided on the northeast corner of our property. You are expected to clean up after your dog. Scoopers are available at various locations on the grounds for your use.

NON-REGULAR CLASSES (VETERANS)

The Veterans class shall be for dogs that have an obedience title and are seven or more years old prior to the closing of entries. The exercises shall be performed and judged as in the Novice class.

SPECIAL NOTICE RELATED TO THE COVID-19 VIRUS

The first priority of The German Shepherd Dog Training Club of Chicago, Inc. is the safety of all our exhibitors and individuals involved in helping with this event. Thanks in advance for complying with these rules and guidelines so we have a safe and successful trial. Most of AKC's current recommendations as they apply to outdoor shows will be utilized. Thank you for your consideration for the safety of all attending the trial. More details will be provided when you receive the judging program.

- Please DO NOT COME to our trial if you feel sick, or if you have tested positive or have been exposed to Covid-19 in the last 14 days before the trial. DO NOT COME if you are concerned about being exposed to the Coronavirus. Please do not enter if you are not willing to follow the rules.
- Please bring a face mask to the trial. We are NOT requiring exhibitors to wear a mask while showing in the ring due to the heat; however, we are requiring that everyone wear a mask everywhere else on club grounds. You will not be able to enter the building without wearing a mask.
- Please maintain 6' social distancing while interacting with anyone at the show.
- Disinfecting spray will be available in the restrooms. Please spray down anything you touch while in there.
- Hand sanitizer will be available in areas through the grounds for use. However, please wash your hands using soap and water as frequently as possible.
- There will not be crating in the building for dogs. Please crate your dogs in your car.

COVID-19 RISK AND LIABILITY AGREEMENT:

If you participate in, enter, or attend any event hosted by the German Shepherd Dog Training Club of Chicago, Inc., you will be deemed (without having to sign any document) to have agreed to the following indemnification, waiver of liability and assumption of risk agreement.

DIRECTIONS TO GERMAN SHEPHERD DOG TRAINING CLUB

FROM THE NORTH: Take the Elgin-O'Hare Expressway to the Lake Street Exit and turn West. Take Lake Street to the first traffic light, Ontarioville Road, and turn South (left). Take Ontarioville 0.5 miles to County Farm Road and turn South. Continue South about 2 miles.

FROM THE SOUTH: Take Route 53, I-355 Tollway, or Route 59 to Army Trail Road. Take Army Trail Road to County Farm Road and turn North. Schick Road is the first traffic light - continue North about 0.5 mile.

FROM LAKE STREET: Take County Farm Road South to the Club, or take Gary Avenue off Bloomingdale Road South to Schick Road. Turn right (West) on Schick Road to County Farm. Turn right (North) on County Farm Road. Continue North about 0.5 mile.

FROM THE WEST: Take North Avenue (Route 64) to County Farm Road, turn left (North) on County Farm Road. Schick Road is the first traffic light - continue North about 0.5 mile.

FROM THE EAST: Take North Avenue (Route 64) to County Farm Road, turn right (North) on County Farm Road. Schick Road is the first traffic light - continue North about 0.5 mile.

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, particolor); Beagles (not exceeding 13" in., over 13" in., but not exceeding 15" in.); Dachshunds (longhaired, smooth, wirehaired); Collies (rough, smooth); Bull Terriers (colored, white); Fox Terrier (smooth, wire); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles and Ruby, Bienenheim and Prince Charles); Poodles (toy, miniature, standard).
