TRIAL SITE DIRECTION

From the North: Take Highway 101 south to E. DONOVAN. Turn Right. Make a quick left on N. COLLEGE DR. Turn Left on N. BRADLEY RD. to the Elk's Lodge.

From the South: Take Highway 101 North to E. DONOVAN. Turn Left over the freeway. Left on N. COLLEGE DR. Turn Left on N. BRADLEY RD. to the Elk's Lodge.

Notice to Exhibitors

Entries close at 6:00 PM Wednesday, August 25, 2021, after which time entries cannot be accepted, canceled, changed or substituted, except as provided for in Chapter 11 Section 6 of the dog show Rules,. There will be a \$2.00 fee charged for cancellation of an entry prior to the closing of entries.

RETURNED CHECKS do not constitute a valid entry fee. Fees must be paid in guaranteed funds.

Entries not on Official AKC Forms or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC entry form are not acceptable. Entry Form must show the name of the Club and the date of the show. Entry Form **MUST BE SIGNED**.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by phone are not acceptable. Move-ups allowed until 30 minutes prior to start of trial.

Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or banned from competition by action of the Show Committee. Refund of entry fees for bitches that come in season after closing date of this show may be obtained by sending a veterinarian's certificate to the Trial Secretary. This certificate must be postmarked before the opening day of the show or given to the Trial Secretary before the start of the show.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the Club or the Trial Secretary.

Dogs must be ready for judging. Neither the club nor its Trial Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **OWNERS OR AGENTS ALONE ARE RESPONSIBLE FOR THE PRESENCE OF THEIR DOGS IN THE JUDGING RINGS.**

Dogs need be present only for their judging. Dogs not needed for further judging may be removed from the show grounds.

It is advised that owners and agents be familiar with the Agreement on the reverse side of the entry form.

All persons attending this dog show hereby waive any claim for damages against The Santa Maria/ San Luis Bay German Shepherd Dog Club or its members, OR the Santa Maria Elks Lodge or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

The Show giving Club, the Trial Secretary, their agents, employees, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injuries to children.

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed on the day of the show. None will be mailed.

By attending this event, you acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present and agree not to hold the superintendent liable for any illness or injury.

By attending this event, you voluntarily assume all risks related to exposure to COVID-19 and agree not to hold Jack Bradshaw Dog Shows, its owners, employees, or volunteers liable for any illness or injury.

IMPORTANT NOTICE: EXHIBITORS SHOULD FOLLOW THEIR VETERINARIAN'S RECOMMENDATION TO ASSURE THAT THEIR DOGS ARE FREE OF INTERNAL AND EXTERNAL PARASITES, ANY COMMUNICABLE DISEASES, AND HAVE APPROPRIATE VACCINATIONS.

SPECIAL COVID-19 TRIAL GUIDELINES

We will be adhering to State of California, County of Santa Barbara, and City of Santa Maria public health regulations in addition to CDC and AKC guidelines. Our aim is to keep our judges, volunteers and exhibitors as safe as possible.

1. If you feel unwell, have a fever, cough, sneezing, sore throat, (or any others symptoms that have been associated with COVID-19), please stay home.

2. If within 14 days prior to the trials you have been in the presence of a person who has either tested positive for COVID-19 or has the symptoms noted above, please stay home.

3. Physical Distancing: Maintain at least six feet between you and other exhibitors or spectators at all times. Avoid congregating to the extent possible. Avoid physical contact, (shaking hands or hugging). Avoid touching dogs that are not your responsibility,

4. Face Masks: Per State of California health orders, face masks are required at all times while outside of one's home where physical distancing is not possible. The show committees plan on allowing exhibitors to lower their face mask while in the ring exhibiting. Anyone lowering their face mask while in the ring must correctly reposition their mask before exiting the ring. Please note that additional public health orders put in place on or before the day of our trials may not allow this. Anyone who refuses to wear mask outside the ring will be required to leave the show grounds.

Exhibitors must supply their own masks!

5. Parking: Park with increased distance between vehicles wherever possible. This is especially critical if handlers are crating from their vehicles.

GENERAL PRACTICES

Exhibitors should wash hands as frequently as possible,

Exhibitors must provide their own method for cleaning up from their dogs in and around show grounds.

Prepare to be self-sufficient: bring sanitizer, bring personal use masks.

Know the armband numbers for your entries before going to the ring.

Do not congregate at the ring or ring gate.

SPECIAL NOTICE RELATED TO THE COVID-19 VIRUS

If you participate in, enter, or attend any event hosted by the Santa Maria / San Luis Bay German Shepherd Dog Club or any Club affiliated with the German Shepherd Dog Club of America, you will be deemed, **(without having to sign any document)** to have agreed to the following indemnification, waiver of liability and assumption of risk agreement.

INDEMNIFICATION, WAIVER OF LIABILITY AND ASSUMPTION OF RISK

I acknowledge and agree that The German Shepherd Dog Club of America, Inc., the AKC Regional Club or SV Regional club hosting or co-hosting the event, and the American Kennel Club, and each of their members, directors, governors, officers, agents, the superintendents and/or event secretary, and the owner and/or lessor or operator of the premises and any provider of services that are used to hold the event(s) and any employees or volunteers of the aforementioned parties, other participants, and any judge judging at the event (**collectively, the "Released Parties"**) are participating in the event(s) and allowing me to enter, participate in and/or attend the event(s) **in reliance** on my agreement to this indemnification, waiver of liability and assumption of risk agreement.

I understand that the AKC Regional Club hosting or co-hosting the event has **the right to refuse** my participation in, or attendance at the event(s), in **consideration** of permitting my participation in, or attendance at the event(s) and of the holding of the event and/or the opportunity to have dogs judged and to win prizes, ribbons, or trophies.

1. I UNDERSTAND THAT PARTICIPATION IN, OR ATTENDANCE AT ANY EVENT(S) INCLUDES POSSIBLE EXPOSURE TO RISK OF SERIOUS ILLNESS AND/OR DEATH AND OTHER RISKS FROM THE COVID-19 VIRUS AND OTHER INFECTIOUS DISEASES.

AGREEMENT

I (we) acknowledge that the "Rules Applying to Dog Shows", and the "Rules Applying to Registration and Discipline" and, if this entry is for an obedience trial, the "Obedience Regulations," and, if this entry is for a rally trial, the "Rally Regulations," have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under AKC Rules, Regulations, and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies. I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury to the dog, whether such loss, disappearance theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

INSTRUCTIONS

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles, Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show class). Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to AKC (For complete rule, refer to Chapter 15, Section 3).
