Additional COVID Guidelines / New Jersey State Guidelines

There are no numerical limits for indoor or outdoor gatherings.

BRED-BY-EXHIBITOR CLASS

Effective September 18, 2002: 1) All dogs entered in the Bred-By Class must be individually registered with the AKC; 2) The individual handling the dog in the Bred-By Class must be a breeder of record and a current owner of record of the dog; 3) To exhibit in this class, family members must be a breeder and owner of record. In any subsequent classes for which a dog from the Bred-By Class becomes eligible, there are no restrictions as to who may handle the dog.

ATTENTION EXHIBITORS

Neither DELAWARE VALLEY GERMAN SHEPHERD DOG CLUB, THE GERMAN SHEPHERD DOG CLUB OF AMERICA, nor anyone connected with the presentation of these events, assumes any responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to their families or children.

The American Kennel Club Rules and Regulations will govern these Events. Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry form that accompanies this Show Premium List.

An Event Service Fee of \$3.00 and a Recording Fee of \$.50 will be required for each dog entered at any Licensed or Member Club Show. These fees are to be collected by the show-giving club and paid to The American Kennel Club. If a dog is entered in more than one class, the Recording Fee is to be collected on the first entry only (AKC Rule, Chapter 15, Section 2).

ENTRIES RECEIVED WITHOUT FEES will not be accepted.

RETURNED CHECKS do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$40 to the amount of each returned check.

TELEGRAPH, TELEPHONE and UNSIGNED ENTRIES CANNOT BE ACCEPTED.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

ERRORS ON ENTRY BLANKS. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

NO REFUND FOR DUPLICATE ENTRIES. We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made. ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances or other acts beyond the control of the club it is impossible to open or to complete the show, no refund of entry fee will be made.

Refunds for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent **AFTER THE SHOW**. An administrative fee of \$4.00 will be withheld from all refunds for entries cancelled prior to closing.

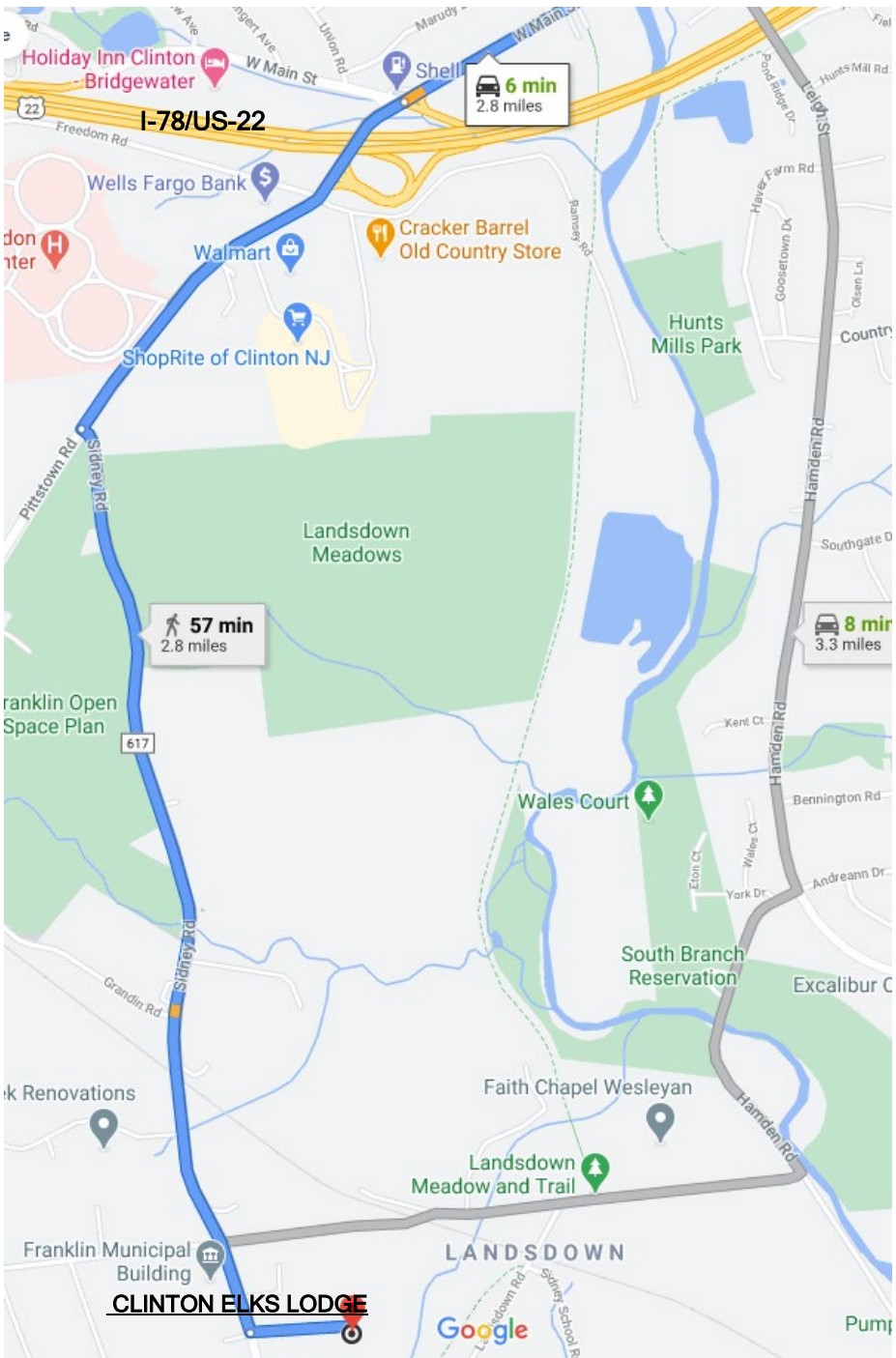
