DIRECTIONS TO THE SHOW SITE FROM THE NORTH OR SOUTH ON I-5: Take the Auburn Exit (Hwy. 18). Go to Auburn and take the Enumclaw Exit to Highway 164. Follow the signs to Enumclaw (Highway 410), just before Enumclaw. Turn right on 244th, go to 456th and turn left. It becomes Warner. Stay on Warner to the fairgrounds.

GOING SOUTH ON I-405 OR COMING FROM THE RENTON AREA – Go east on Maple Valley Highway (Hwy. 169), go through Black Diamond and continue on 416th SE, turn left then follow signs to the fairgrounds.



INSTRUCTIONS FOR ENTRIES

Use one entry blank per dog only if information is exactly the SAME for each day. Carefully check the block (blocks) for each show in which you wish to enter your dog. You **MUST** use a **SEPARATE** entry blank if you are entering your dog in a

different class on different days. (e.g. Open Class on Day 1 and American-Bred Class on Day 2), or, if you are entering an additional class on any of the days (Open Class on Day 1 and Open Class plus Jr. Showmanship on Day 2 or Open Class and Novice A Obedience on Day 2.)

INSTRUCTIONS FOR ONLINE PAYMENT OF ENTRIES

Go to www.paypal.com. Log in or set up your new account. Click on Send & Request. In the "name" field type in showsecretary@anarak.org or select it from your manage contacts. In the Add A Note section, enter the name of the show giving club, your dog's registered name and/or the dog's AKC number so your payment can be credited correctly. Enter the total amount due that you are sending. Be sure to add the \$2.50 fee to each entry. If you need help determining how much to send, call me at 360-669-0649. Once you have entered the correct amount, select Send To A Friend. Choose the financial institute you set up in your account. Review your transaction and hit Send Payment Now.
