Notice to Exhibitors The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 24 hours, please call the Trial Secretary by telephone.

Entries must be made on Official AKC Entry Forms or copies and must include the signed Agreement and Rules. Please include only AKC titles on your entries.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures. Post Dated and Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the veterinarian, judge, or Trial Committee.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Exhibitors are responsible for being at the gate when it is their turn to run. The judge need not wait for any dog holding up a class. GSDCA has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the area when required.

Bitches in season will be permitted to run, but will be placed at the end of the running order in Tests and in catalog order for Trial classes.

Dogs must wear a simple well-fitting buckle, snap lock, or slip collar, in Tests; for Trial Levels, a dog may run without a collar, or one of those listed above. Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date other than move ups. No refunds for duplicate entries. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

All dogs must be on lead or crated at all times except when in the arena. See Chapter 1, Section 20 of the AKC Herding Regulations.

Exhibitors are responsible for cleaning up after their dogs at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

The safety of the dog is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

Herding Victor/ Victrix Title Trophy

Danny Quest Cold Cast Bronze Sculpture of GSD with Sheep and special black and red rosette awarded to the GSD with highest qualifying score from the Advanced (sheep only classes on Courses A, B, or C and judged by the designated GSDCA National judge, Rusty Jeffers from the designated National trial (Sunday 9/18 for the National C Course trial held in Spencer, MA). In case of a tie, AKC Herding tie breaking rules will apply and be followed. Spayed or neutered dogs are acceptable. Owner of winning dog must be a member of the GSDCA. Only AKC registered German Shepherd Dogs with a known AKC pedigree (no ILP/PAL "listed" dogs") are eligible to win the Herding Victor/Victrix award. The Herding Victor/Victrix must be free of disqualifying faults as stated by the AKC GSD Standard and as verified at time the Award is given by an AKC judge approved to judge German Shepherd Dogs. The winner of the Herding Victor/ Victrix GSDCA award will be presented with their trophies to the membership in the main arena at a time designated by the National Show Coordinator and the winning dog/bitch will also be announced with other winners at the Victory dinner.

Special Awards

Special Rosettes will be awarded to the highest scoring GSD from any class or stock in each of the following categories: Breed Champion, Breeder/Owner/Handler, Veteran (7 or older) with IPO, IGP, or Sch Title, with Tracking, Obedience, Agility, or Rally Titles, for Rescue or White GSD, or Junior Handled. Eligible categories must be indicated on the Special Award Form at time of entry. Titles must be recorded with AKC by August 31
