**ENTRIES OPEN: August 1, 2022, at 8:00 a.m. (EST) ; non GSD

CLOSING DATE: September 22, 2022, 6 pm, after which time entries
cannot be accepted, canceled or substituted except as provided for in

CANCELLATION OF ENTRIES BEFORE CLOSING: Entries cancelled
before closing will not be charged any processing fees. Entry checks will
be shredded.

REFUNDS: There shall be **no refunds for entries withdrawn after the
closing date in the event a dog and/or handler are injured, absent,
or dismissed from competition**, regardless of the reason for such
dismissal. If because of riots, civil disturbances or other acts beyond the
control of management it is impossible to open or complete the show, no
refund of entry fee will be made. If a waitlist exists, and your entry could
be replaced, then a full refund would be given for the runs that can be
replaced, no fees taken.

BITCHES IN SEASON are not eligible to participate. Entry fees will be

MOVE UPS

As per Chapter 1, Section 20, American Kennel Club Regulation for Agility Trials, dogs may be moved up to a higher class, at the request of the Owner, as a result of qualifying for an agility title. Dogs so moved up will be entered at the end of the running order or otherwise at the secretary's or Judges discretion. **EMAILED MOVEUPS:** When emailing a moveup to us please just give the following information: TRIAL NAME, Owner Name, Dog Call Name, Move up for what days (Saturday, Sunday, etc.), Moving from, Moving to (PLEASE include STD or JWW). **NOVICE MOVEUPS: Dogs or Handlers having attained ANY AKC Agility Title must be moved to the Nov B Classes.** Before the trial move-ups may be made prior to the move-up deadline via email to the trial secretary <mailto:joneills@verizon.net>. Verbal move-ups will not be accepted. Move-ups for the first day are due in writing by **Monday at 6 pm** the week of the trial. **Day-to-Day Move-ups** must be submitted in writing at the trial within ½ hour of the last run of the trial day for the following day(s) and cannot be conveyed via fax, email, or verbally to the trial secretary.

Premiums, confirmations, pre-trial running orders (after move-ups are processed), and results will be posted to www.barc4agility.com.

Individual results will be emailed out after the trial.

ONLINE ENTRIES

This trial is accepting online entries through **LabTestedOnline.com**. Go to <http://www.labtestedonline.com> to create a user account and add your dogs. Then look for the trial on your My Local Events page or search by state for (state). Click on the "i" information icon to the right of the club's name to create your entry. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: 50 runs online, 300 runs paper each day. If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

JUMP HEIGHT CARDS

You are no longer required to send a copy of your dog's height card/form with your entry. However, please check the box on the entry form that states you need to be measured if this is necessary. Remember, it is your responsibility to carry your permanent card and or measurement form with you as proof of your dog's height. If you need to have your dog measured, this must be done **BEFORE** you run! (*Regulations for Agility Trials, Chapter 2, Section 4*)

TRIAL SITE RULES

- **YOU ARE RESPONSIBLE TO CLEAN UP AFTER YOUR DOG. If you are caught not cleaning up after your dog you may be asked to leave the site – no refunds will be given.**
 - ****ALL DOGS ARE TO BE EITHER ON LEASH OR CONTAINED IN A SECURE LOCATION AT ALL TIMES UNLESS THEY ARE IN THE RING. PER AKC RULES NO DOGS ARE TO BE RUNNING FREE ON THE ENTIRE PREMISIS UNLESS THEY ARE IN THE RING. THIS WILL BE STRICTLY ENFORCED AND THOSE FOUND IN VIOLATION ARE SUBJECT TO BEING ASKED TO LEAVE WITHOUT ANY REFUNDS****
 - The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
 - Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.
 - No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
 - It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the Trial site. In such case, no refund of any fees paid will be made.

RIBBONS & PRIZES (GSD only days)

Double Flat Ribbons will be awarded for all placements.

Double Flat Ribbons will be awarded to all dogs receiving a qualifying score.

New Titling Ribbons will be awarded to all dogs earning a new title.

Agility Victor/Victrix Award

Danny Quest cast trophy and Rosette

Agility Victor/Victrix will be awarded from the Regular Master Standard and Regular Master JWW classes using the following criteria:

- The dog must be entered both days of the trial
- The dog must qualify in BOTH the Regular Master Standard and the Regular Master JWW classes, therefore earning a Double Qualifier (QQ) on one or both days of the trial. Only Double Qualifiers will be used in determining the Agility Victor/Victrix.
- Double Qualifying on both days will supersede any single day QQ.
- If more than one dog earns a QQ on both days, or if only a single day QQ's are earned on the same day, then the dog with the lowest combined total time for those runs will be awarded the title of Agility Victor/Victrix.
- In the event of a single day QQ's being earned on different days the dog with highest yards per second* will be awarded the title Agility Victor/Victrix.
(*YPS = total yards of the courses that the QQ was earned on divided by the dogs' times)

In the case that no dog earns a QQ on either day the award will not be given.

CRITERIA FOR THE AGILITY VICTOR/VICTRIX.

In addition to the above scoring criteria the following must be met.

1. Must have an AKC Registration number (PAL/ILP dogs are not eligible)
2. Spayed/neutered dogs are acceptable.
3. AT LEAST ONE OWNER MUST BE A MEMBER OF THE GSDCA.
4. Dog has no disqualifying faults per breed standard

The following special awards will receive glass trophy with acrylic stand:

High Scoring GSD from regular classes

High Scoring GSD from preferred classes

Placement in each class

The following special awards will receive rosettes:

High Scoring GSD in regular classes

High Scoring GSD in preferred classes

High Scoring Breed Champion in regular classes

High Scoring White GSD

High Scoring in STD with a PAL/ILP number

Awards will be decided by using the following criteria:

- The dog must be entered in Regular Standard class both days of the trial.
- The dog must qualify in a Regular Standard class on one or both days of the trial.
- Dogs qualifying both days in Regular Standard will have their two-day combined qualifying scores totaled. The dog with the highest total will win.

• In the event of a tie score, yards per second* (YPS) will be determined for both runs. The dog that has the highest YPS average will be awarded that award that they are eligible for.

• If no dog qualifies both days but qualifies only on one day making it still eligible, the dog with the highest score will win. If there is a tie the dog that has the highest YPS* will be awarded that award that they are eligible for.

***YPS = total yards of the course(s) that the qualifying runs were earned on divided by the dogs' time(s)**

In the case that no eligible dog earns a qualifying score in Regular Standard in any of the levels the award(s) will not be given.

* In order to be eligible for the High Scoring Breed Champion of Record Award, the dog must be a Champion when you sign up for the award on the first day of the trial.

*** All criteria are the same as for the High Scoring PREFERRED German Shepherd except you must be entered in the preferred class rather than the regular class to be eligible. GSDCA Awards will be presented on Wednesday at the conclusion of the judging. Dogs must earn qualifying scores to receive any special club awards.

High Scoring Junior Handler

High Scoring Jr Handler will be awarded from a combination of Regular Standard and Jumper w/Weaves classes using the following criteria:

• The dog must be entered in Regular Standard and Jumpers w/Weaves classes both days of the trial.

• The dog must qualify in at least one class on one day or the other. If a dog qualifies in both classes on the same day that will supersede a single qualifying score.

• If two dogs qualify in both classes on different days, then the scores will be combined. They will still supersede a single qualifying score each day.

• If only single qualifying scores are earned both days those scores will be combined.

• Scores will be used to determine the winner. In the event there is a tie with scores the winner will be decided by the highest *YPS average.

• If no dog qualifies in any class either day the award will not be awarded.

***YPS = total yards of the course(s) that the qualifying runs were earned on divided by the dogs' time(s)**

Junior Handler's dogs must be owned or co-owned by the Jr Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including the corresponding step and half relations, or by a permanent member of the Jr Handler's household.

****TRIAL REGULATIONS FOR EXHIBITORS****

ACKNOWLEDGEMENT OF ENTRIES will be made as soon as entries are processed. Acknowledgment of entries will include confirmation notices.

CONSULT FINAL CONFIRMATION FOR TIME OF JUDGING AND SCHEDULE.

DOGS This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), AKC Canine Partners listing number (if the trial-giving club is offering the option of Canine Partners entries. See front page of the premium for that information), or approved Foundation Stock Service (FSS) breeds are eligible to participate. All American dogs that have been listed with AKC Canine Partners may participate if the trial-giving club is offering the option of mixed breed entries and provided their listing number has been recorded on the entry form. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

DOGS MAY ARRIVE any time prior to judging, otherwise, they must be available for measuring before their class begins.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules attached to the Official AKC Entry Form are **NOT ACCEPTABLE.**

ENTRIES RECEIVED WITHOUT FEES will not be accepted.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the match, no refund of entry fees will be made.

ERRORS ON ENTRY BLANKS-Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

FAX, TELEPHONE AND UNSIGNED ENTRIES cannot be accepted.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. If you are not present when it is your turn, you will be marked absent. Please be at the line on time!

MOVE-UPS – The deadline for move-ups for the trial is 6pm on the Monday before the trial. Day to day move-ups are accepted for up to ½ hour after completion of the last run.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.

TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

WAITLIST – If needed a waitlist will be held until move-ups have closed the Monday before the trial. Only entry fees replaced with someone from the waitlist will be refunded.

WALKTHROUGHS – will be determined by the final confirmation.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

Entering for Exhibition Only (FEO)

(Competitor note – by publishing this information, it informs you that the club is offering this at the event.)

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring:
 - Toys must be non-audible
 - Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

DIRECTIONS

Traveling I-75 South: Take Exit 358 to FL-326 and turn a slight right off the exit ramp. After 2.28 miles turn left onto NW Hwy 225A. Approximately 3 miles take a slight right onto NW 80th Ave/FL 225A. In 2.11 miles, the WEC will be on the right.

Once on the property, follow the signs to Expo 2.

Traveling I-75 North: Take Exit 352 onto FL-40 toward Silver Springs/Ocala. Keep left and take the ramp toward Dunnellon and turn left onto W. Silver Springs Blvd/FL 40. In approximately 4 miles, turn right onto NW 80th Ave. The WEC will be on the left in 1 mile. Once on the property, follow the signs to Expo 2.
