ATTENTION EXHIBITORS

AKC recording fee of \$0.50 will be collected for each individual dog on the first entry only. The AKC also requires \$3.00 Event Service Fee for first entry of a dog and a \$3.00 Service Fee for each additional entry of same dog in regular & non-regular classes. These fees are to be collected by the show giving club and paid to the American Kennel Club. (American Kennel Club Rules, Chapter 11, Section 2 amended).

The Show Giving Club assumes NO responsibility for any loss, damage, or injury of exhibitors, handlers, or any of their dogs or property and assumes no responsibility for their children.

All Cash Prizes, Ribbons, and Trophies will be given in the ring to the person showing the dog. Claims for ribbons, trophies, or prize money must be made in the ring before the judging of the class is over. The German Shepherd Dog Training Club of Chicago, Inc. reserves right to substitute prizes/ribbons/trophies if needed and disclaims any liability for cash prizes, ribbons, and trophies after the judging of the class is over. Absolutely no Trophies, Ribbons, or Prizes will be mailed.

The German Shepherd Dog Training Club of Chicago, Inc. believe in responsible dog ownership. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. For your convenience, an exercise area is provided on the N/E corner of our property. You are expected to clean up after your dog. Scoopers are available at various locations on the grounds for your use.

No dogs will be allowed on the show grounds that are not entered in this trial. All dogs entered in the trial must remain on leash or be confined to their crates, except when required in the ring for competition.

Entries close **Wednesday, February 1 at 7:00 pm**, after which time entries will not be accepted, substituted, cancelled or changed except as provided for in Chapter 1, Sec.16 of the Obedience Regulations. Transfers will be allowed and changes may be made per Sec 16A and 16B of the Obedience Regulations. Transfers and changes must be in writing and presented to the Trial Secretary no later than 30 min prior to start of first class.

All entry changes or cancellations, except those resulting from a judge change, must be made in writing, by mail or email and received by the trial secretary prior to the closing date and time.

Females in Season are not permitted to compete. If a female is withdrawn from competition because it came into season, the Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. The club will refund the entry fee, minus a \$10.00 processing fee. The Club will require documentation from the Veterinarian confirming the female to be in season before a refund can be given.

Entry fees will not be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of public enemy or any other cause beyond our control of the organizing committee.
