**Bred by Exhibitor Class Eligibility:** 1) All dogs entered in the Bred by Exhibitor class must be individually registered with the AKC, 2) the person handling the dog must be a breeder of record of the dog and an owner of record of the dog.

#### EXHIBITOR RULE CHANGE EFFECTIVE 01/01/2011

Chapter 11, Section 1. No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. For complete details see Rules Applying to Dog Shows, Chapter 11, Section 1.

### Non-Regular Classes

#### Classes offered for each sex:

**Veteran Classes:** For dogs or bitches seven (7) years of age or older on the day of the show. Neutered dogs and spayed bitches may compete in the Veterans Class.

1<sup>st</sup> Veteran dog & 1<sup>st</sup> Veteran Bitch compete for Best of Breed.

#### 4-6 MONTH BEGINNER PUPPY

- The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign-born dog may enter this class if they are registered in the country of origin
- Professional handlers are not permitted to exhibit in this class. Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler.
- All of the puppies of the same breed (not divided by sex) are exhibited in the same class and the only placements are Best of Breed and Best of Opposite Sex to Best of Breed

1. IF MONEY IS OWED TO GOLDEN STATE GERMAN SHEPHERD DOG CLUB OF SAN JOSE, ENTRIES AND PERSONAL CHECKS WILL NOT BE ACCEPTED UNTIL ALL MONEY OWED IS REMITTED BY MONEY ORDER OR CASHIERS CHECK. RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY.
2. The club assumes no responsibility for a wrong entry. Please PRINT or TYPE all information on entry blanks.
3. During the hours of judging, owners are to be on call and to have their dog ready to be brought into the judging ring promptly so the judging will not be delayed.
4. It is the responsibility of the exhibitor to have his or her dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs are alone responsible for the presence of their dogs in the judging rings.
5. There is no rule of this Club or of the AKC that requires a judge to wait for an owner or handler to bring his or her dog into the ring.
6. An exhibitor whose dog is eligible for an award must be present or have an appointed representative to accept the award for him or her.
7. Entry fees will not be refunded if the dog is absent, disqualified, sick, lame, in season, excused by veterinarian or judge, or barred from competition by action of the show committee.
8. Exhibitors and handlers will be held responsible for clean conditions in and around their crates.
9. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is understood that the exhibitor will exercise control over his or her children on the day of the show.
10. The Club assumes no responsibility for dogs or equipment left unattended.
11. All dogs must be kept on leash.
12.
