## DIRECTIONS TO Timber Ridge Pet Resort

Directions:

From the North (I-83 South) to Mt Carmel Road (Exit 27). Travel West on Mt.Carmel Road for approximately 6 miles to Falls Road. Turn South on Falls Road. Travel about quarter of mile and turn right on Ridge Road. Timber Ridge Pet Resort is approximately 1/2 mile on right.

From the South Follow I695 to I83 North. Then follow direction above.
