**BRED-BY-EXHIBITOR CLASS**

Effective September 18, 2002: 1) All dogs entered in the Bred-By Class must be individually registered with the AKC; 2) The individual handling the dog in the Bred-By Class must be a breeder of record and a current owner of record of the dog; 3) To exhibit in this class, family members must be a breeder and owner of record. In any subsequent classes for which a dog from the Bred-By Class becomes eligible, there are no restrictions as to who may handle the dog.

## **LISTING OF AGENTS/HANDLERS IN SHOW CATALOGS**

To be listed as a handler or agent for a dog in catalogs for events occurring on or after January 1, 2025, individuals must successfully complete the Stewards of Children® course and submit their certificate of completion along with a completed Agent Number Request form to [judgecompliance@akc.org](mailto:judgecompliance@akc.org). The new agent number should be used for events occurring on or after January 1, 2025, and will be accepted by all superintendents. AKC RHP & PHA Handler numbers will be retained as they are already accepted universally.

## **ATTENTION EXHIBITORS**

Dogs need to be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the clubs nor show secretaries will be responsible or obligated to furnish any service for notifying exhibitors or their agents of class being judged. All dogs present must be held on leash or confined to their crates.

Judges need not wait for any dog holding up the judging of a class. Owners or their agents alone are responsible for the presence of their dog(s) in the judging ring.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or a judge; or barred from competition due to their violation of any rules or regulations set forth by the show-giving clubs.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures. Changes, additions, or corrections to entry forms must be received in writing or by electronic mail, telegram or fax prior to the close of entries. Entries received by telephone are not acceptable.

No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, an Act of God, public emergency, act of public enemy, strikes, or any other cause beyond the control of the show-giving club or show secretary.

The show-giving clubs, the show secretaries, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property and, further, no responsibility for injury to children.

An Event Service Fee of \$3.00 and a Recording Fee of \$.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial, or Tracking Test. These fees are to be collected by the show-giving club and paid to The American Kennel Club. If a dog is entered in more than one class, the Recording Fee is to be collected on the first entry only (AKC Rule, Chapter 15, Section 2).

**ALL videotaping or photography during the show requires permission from the show-giving club. Only the Official Show Photographer is allowed to photograph win photos.**

ALL prizes must be claimed the day of the show—none will be mailed.

NO SMOKING is allowed in the Happy Tails Ranch facility.

NO SPACE PROVIDED for unentered dogs.

## **BELOW ARE RULES THAT MUST BE FOLLOWED:**

1. ALL DOGS TO BE EXERCISED IN DESIGNATED AREAS ONLY, both at the show site and at area hotels (if so designated).
2. Dogs must be kept on leash at all times while on show or hotel grounds.
3. Limit of 2 dogs per hotel room (unless otherwise specified by respective hotels). Plastic (if available at check-in) is to be placed under each crate in hotel room.
4. Unattended dogs must be crated in hotel rooms.
5. Absolutely no bathing or grooming of dogs is allowed in hotel rooms.
6. Dog owners/agents are responsible for timely clean up and disposal of any waste - both at show grounds and at their respective hotels.
7. Dog owners and/or their agents are personally responsible to area hotels for any damage caused thru their negligence.

I-94W/I-294N/I-94W to Newport Township IL. Exit #2 for IL-173 / Rosecrans Road. Follow IL-173 for 4 miles. Left on Savage Road. Proceed ½ mile, turn right on West White Road. Destination will be on the right.

### **From Kenosha WI**

I-94 East. Entering Illinois. Use left 2 lanes to take exit 1B for US-41 S toward Waukegan. Continue onto US-41S/US Hwy 41. Turn right onto IL-173 W / Rosecrans Road. Proceed as above.

## **DIRECTIONS TO VETERINARY CLINIC FROM SHOW SITE**

Head southeast on West White Road. Turn right onto Savage Road. Proceed 1.7 miles. Turn right onto County A10/West Grass Lake Road. Proceed 3.6 miles; turn left onto Illinois Route 59S. Proceed 9.2 miles. Turn right onto North Fox Lake Road. Proceed 0.8 miles, turn right onto Volo Village Rd. Proceed 0.1 miles Turn right onto IL-120 West. Proceed 0.2 miles turn left onto N Fisher Rd. Go 1.4 miles, turn left onto County V47/North Darrell Road. Proceed 0.2 miles, turn right onto Dowell Road. Beagles (not exceeding 13 in.; over 13 in. but not exceeding 15 in.) Dachshunds (longhaired, smooth, wirehaired). Collies (rough, smooth). Bull Terriers (colored, white). Manchester Terriers (standard, toy). Chihuahuas (smooth coat, long coat). English Toy Spaniels (King Charles & Ruby, Blenheim & Prince Charles). Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record and dogs, which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
